Terms and Conditions

PURPOSE

This form is to be used by individuals wishing to apply for membership with Asset Firearms Pty Ltd (ABN 19 610 870 650) trading as Asset Firearm and Crossbow Club.

WHAT MEMBERSHIP COVERS

Financial members of Asset Firearm and Crossbow Club are registered as members of the Shooting Club (approval number 80001564), the Weapons Club (approval number 80001565) and the Historical Society (approval number 49001014).

This membership aligns with the genuine reasons for sport/target shooting with rifles, shotguns, handguns and crossbows as well as the collection, study and preservation of weapons as outlined in the Weapons Act/Regulation.

Asset Firearm and Crossbow Club will schedule a sufficient number of events each year for members to meet the minimum attendance requirements for each of the above genuine reasons to hold a weapons licence in QLD. Members are entitled to attend and participate in organised events and training, hosted by Asset Firearm and Crossbow Club at the discounted member rates.

WHAT MEMBERSHIP DOES NOT COVER

Membership does not include any costs associated with licensing, range access or use of equipment other than that which is specified for particular events.

ACCEPTANCE OF MEMBERSHIP APPLICATION

Asset Firearm and Crossbow Club may at its sole discretion accept or reject applications for membership without providing reasons. If accepted, membership will commence from the date of the approval.

Members agree to adhere to all terms and conditions, policies, procedures and instructions provided to them by authorised representatives of Asset Firearm and Crossbow Club. This includes but is not limited to range standing orders when using range facilities owned by third parties.

Members agree to always act in a safe, lawful and ethical manner to promote a professional and positive image of the club and the industry. This applies while participating in club activities and any other time where the reputation of the club may be impacted by the behaviour of the member.

Members agree to exercise reasonable skill and care when using club and third party resources, equipment and facilities. Members may be personally liable for damage they cause to property as a result of deliberate or negligent actions which are in breach of Asset Firearm and Crossbow Club's policies and procedures.

TERMINATION OF MEMBERSHIP

Membership may be terminated by Asset Firearm and Crossbow Club at any time if a member fails to adhere to the terms and conditions of membership.

Members may voluntarily terminate their membership by providing the club with 14 days' notice in writing.

REFUND POLICY

Application Fees and Membership Fees are non-refundable. Memberships and associated fees are not transferrable.

Fees paid in advance for events and training may be refunded or credited to a members account (unless otherwise stated for the specific event) where the member provides at least 5 business days' notice of their cancellation in writing.

USE OF FACILITIES AND EQUIPMENT

Asset Firearm and Crossbow Club will provide access to facilities and equipment for use by members. These facilities and equipment may be owned by Asset Firearm and Crossbow Club or a third party with a written agreement authorising its use. Members agree to use the facilities and equipment for the purpose of approved club and training activities only; in accordance with standard operating procedures; in accordance with range approvals, licensing and other regulatory requirements; for the purpose and within the capacity for which it was designed and in a safe and responsible manner.

SUPERVISION

All members and non-members participating in Asset Firearm and Crossbow Club activities, regardless of occupation, licences, experience or any other factor are to follow all directions and instructions provided to them by the nominated Asset Firearm and Crossbow Club authorised representative. Any participant who disagrees with the directions provided agrees to withdraw themselves from the activity.

DISCLOSURE OF INFORMATION

Members agree to disclose all relevant information to Asset Firearm and Crossbow Club authorised representatives regarding their suitability to hold membership as a fit and proper person in accordance with the Weapons Act/Regulation; their licence status including occurrences of cancellation or suspension of their licence; and any medical or other issues which may impact on their suitability or fitness to participate in club activities and/or training.

PRIVACY STATEMENT

Asset Firearm and Crossbow Club collects and uses personal information in accordance with the Australian Privacy Principles and the Privacy Act 1988 (Cth).

Your personal information contained in this application form, provided by you or an authorised third party, your membership status and participation data may be used or disclosed by Asset Firearm and Crossbow Club to provide membership services and for statistical, regulatory or research purposes. Asset Firearm and Crossbow Club may disclose your personal information for these purposes to third parties, including Commonwealth and State/Territory Government departments and authorised agencies.

Sensitive personal information will only be used by us for the primary purpose of which it was obtained, a purpose which is directly related to the primary purpose, with your consent, or where required or authorised by law.

Personal information may also be used to provide you with marketing and communications about Asset Firearm and Crossbow Club membership, events and training. Members may opt-out of marketing communications at any time.

ASSUMPTION OF INHERENT RISK

Applicants for membership understand fully that participation in Asset Firearm and Crossbow Club activities, events and training can be inherently dangerous and as such may cause injury or injuries which may be categorised as minor, serious or catastrophic, these injuries may include permanent disabilities, spinal injuries and paralysis, stroke, heart attack and even death.

Members understand that it is their own responsibility to inspect the facilities, equipment and areas to be used and if they believe that any are unsafe or pose unreasonable risks, they agree to immediately notify appropriate personnel. By participating in club activities, members acknowledge that they have found the activity, facilities, equipment and areas to be used to be safe and acceptable for participation and accept full and sole responsibility for the condition and adequacy of their own equipment.

Members understand fully the inherent risks involved in club activities that they are willingly and voluntarily participating. By submitting this application, members acknowledge that they: (a) know the nature of the activities; (b) understand the demands of any activities to be undertaken relative to their own physical condition; and (c) appreciate the potential impact of the types of injuries that may result from participation in the activities.

Members knowingly assume all of the inherent risks of the activities and training; and take full responsibility for any and all damages, liabilities, losses or expenses that are incurred as a result of participating in Asset Firearm and Crossbow Club activities. For the avoidance of all doubt, members acknowledge that they are participating in club membership, events and training entirely at their own risk.

WAIVER

In consideration for being permitted to participate in Asset Firearm and Crossbow Club membership, events and training, to the extent permitted by law, members hereby and forever waive, release, covenant not to sue, and discharge Asset Firearms Pty Ltd and the other related parties from any and all claims, actions, suits, demands, losses and other liabilities in relation to any death, physical or mental injury, including but not limited to the aggravation, acceleration or occurrence of such an injury, the contraction, aggravation or acceptance of a disease or the coming into existence, the aggravation, acceleration or occurrence of any other condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs in relation to an individual that is or may be harmful or disadvantageous to the member or the community or that may result in harm or disadvantage the

member or the community however arising out of the acts, omissions or conduct of Asset Firearm and Crossbow Club.

INDEMNITY

To the extent permitted by law, members agree to hold harmless, defend and indemnify (which for the avoidance of doubt includes defending and paying any judgment, court costs, investigation costs, legal fees and other expenses incurred) Asset Firearms Pty Ltd (and the other related parties) from any and all actions, suit, proceedings, claim, demand, damage, penalty, cost or expense (Claim), members or any other person (including but not limited to another participant in the activity) may have arising as a result of or in connection with my participation in the activity. This applies to all Claims however they may arise, including but not limited to Claims arising from the inherent risks of the Asset Firearm and Crossbow Club activity or any negligence of Asset Firearm and Crossbow Club or the related parties.

FITNESS TO PARTICIPATE

Members declare that they are and must continue to be medically and physically fit and able to participate in the club activities. Members are not and must not be a danger to themselves or the health and safety of others. Members must immediately notify Asset Firearm and Crossbow Club, in writing, or any change to their fitness and ability to participate. Members understand that it is their own responsibility to continuously monitor their own physical and mental condition during the activity and withdraw themselves immediately and to notify appropriate personnel if at any point their continued participation would create a risk of danger to themselves or to others.

MEDICAL TREATMENT

Members consent to receiving any medical treatment that Asset Firearm and Crossbow Club or its authorised representatives consider necessary or desirable during or after the activity whilst on the approved range or other premises used for the club activity. Members further agree to assume responsibility for all costs of medical treatment and transportation required under this clause.
